The elective General Assembly of the Aquatic Federation of Guinea was held on March 01, 2025 at the Atlantic View Hotel in Conakry in the Commune of Ratoma Kipé district near the Vocational School of Posts and Telecommunication of Guinea.

The meeting, which took place from 10 a.m. to 3 p.m., was supervised by:

- The Ministry of Youth and Sport
- The Guinean National Olympic and Sports Committee
- 2 Journalists and Sports Consultants.

## 1- Opening Ceremony

After setting up at 10 a.m., the Opening Ceremony began at eleven a.m. (11:00 a.m.) and three (3) speeches were delivered:

The President of the Guinean Aquatic Federation Dr. M'Bambé SAKHO welcomed the delegates (statutory members) and thanked the authorities and partners at all levels (Ministries of Youth and Sports, the Guinean National Olympic and Sports Committee, Africa Aquatics, Zone 2 and World Aquatics) for their invaluable support provided to the aquatic federation during the period ending 2020 – 2024 in the financial fields, training and supervision of the logistics of the administration. These efforts have made it possible to make significant progress in our human resources, to raise our performance and to involve us in a multitude of events that have enabled the federation to increase its performance.

President Dr. M'Bambé has committed on behalf of the Swimming family to meet all challenges during this mandate.




